I work for a department in the foreclosure side of a bank as a mortgage underwriter. Every day I attempt to modify the mortgages of people who are behind on their payments, and adjust the terms of their loan so as to make their home more affordable, so they can resume making their payments, and keep their home. In the process of doing my job, I have occasionally analyzed the tax records and bank statements of people who tithe and make donations to various ministries.

I have seen people who tithe lose their home to foreclosure.

Over the years I have been in the church and involved in ministry, I have known some fantastic Christian people on a very personal level who believed in tithing. I've seen some of these people tithe their way into deep everlasting poverty. I have seen very few people tithe their way out of poverty.

I've seen people "trust God with their finances," but they couldn't keep a bank account open. Either because they were worried about creditors suing them and seizing their assets, or because they couldn't keep a balance high enough to justify a checking account.

I have known people who tithe to have their phones ring off the hook at all hours of the day due to creditors calling for unpaid bills.

I have known people that tithe that have spent years suffering chronic unemployment, who would even tithe from their unemployment checks.

I have known people who tithe that needed people to co-sign for them on a car loan (which means a bank wouldn't lend them money because their credit was trash or they simply didn't make very much money).

I have known people who tithe to drive the most unreliable cars in the world, that constantly breakdown, leave them stranded, and further suck their already limited resources dry.

I have known people who tithe that regularly rely on government aid or the charity of others in order to just survive and have the basics in life.

Some of the people I have known in the above scenarios have been "lay people." But some have also been ordained ministers within the church. And for many ministers in various denominational affiliations, this is a major predicament, because the credentials they hold with their denomination require them to tithe. If they fail to tithe, they could lose their credentials, their church, and their job. So in spite of their extreme financial hardships that some suffer from, they continue to tithe so as to avoid unemployment, or losing a ministry that is precious to them.

Yet, in spite of all these bone crushing hardships people have suffered while tithing, and in spite of going through foreclosure, being behind on bills, being unemployed, and living in deep poverty, I have sat in church and heard some of these same people stand up and testify about how "blessed" they were financially for tithing. If their creditors were in the room, they would disagree. If they are so blessed, and if heaven is so open, why aren't they paying all their bills?

For every story I've heard where somebody stands up, testifies to God's faithfulness in tithing, and then tells stories of groceries left at the door, or receiving anonymous checks in the mail, I know of a hundred other people who went without groceries, and whose mail boxes were full of nothing but "past due" and "shut off" notices. Ashamed, many choose to say little to nothing at all about this in church. Even if they did want to share, many pastors would probably not let them do so

I don't mean for this post to come across as harsh, unloving, or cynical. I'm just attempting to be very real about the things I know and to generate a real discussion about the modern practice of tithing. I am very deeply conflicted about the things I have seen in church over the years, and testimonies connected with people who tithe. I don't think many in the church are being very honest. We are very selective in the stories we tell, and we are guilty of telling half-truths. We ignore a story that could hurt the size of our offering. We don't want the real truth.

Many ministers know of these things, but continue to selectively celebrate "success stories" while deliberately ignoring the stories of people who tested God with their tithe, yet have seemingly seen God fail them. Their selective success stories are like fisherman who tell stories of big catches, but never tell you about the days they caught nothing. Their selective success stories are like professional stock traders who tell stories of 100 percent gains, but don't tell you of the time they saw a stock they own go all the way down to zero.

Some who know of these things will even go so far as to say these failure stories are not evidence of a busted doctrine, but are evidence that the person who was tithing wasn't doing it with the right heart. Or, they will make some other charge of guilt against their brother and sister who was so bold as to give 10 percent of their income, even in the face of financial adversity. Something must be wrong with them and why they tithed but didn't see the results. Then they will go on to rehash a success story they know of, that reinforces the idea that tithing always works, and using it to discount the not so happy story. This my friends is known as propaganda.

As a result, most never bother to genuinely question the doctrine of tithing altogether, and whether or not Christians today are required to tithe, in spite of the knowledge that there are people whose tithing stories aren't so successful. No genuine inquiry and no real "testing" is allowed. No failure stories are kept, recorded, or remembered, except in the memories of people whose financial lives have been turned up-side down because somebody twisted their arm and encouraged them to tithe, and misapplied some promises from the Old Testament.

If we are going to tell people to "test God" in with their tithe, then we better be open and honest about the whole truth of the matter, and tell all the stories of people who tested God with their tithe, only to seemingly see God fail. Some people tithe, and never see heaven so much as crack open an inch. Instead they suffer bankruptcy, foreclosure, unemployment, broken down cars, and outlandish medical bills and other outstanding debilitating issues.

It is my contention that because God does not require Christians to tithe under the New Covenant, the promised blessing of Malachi 3:10-11 has no bearing anymore, and that is why we cannot "test God" in tithing. I believe we are called to a different sort of stewardship and a different form of giving altogether.

It touches on so many of the abuses of churches, especially word of faith churches and those of the prosperity persuasion. In my own experience over 25 years, so many people I knew tithed from fear. They were taught that if they did not tithe they were robbing God and if they robbed God then they would more than likely face poverty. If they wanted to succeed then first and foremost, before anything else, they must pay the tithe. When you go to the many countries of Africa, you can see the extreme results of this teaching. In the church, just like anywhere else, if you say something enough times, promise enough riches and fortune, and get enough people behind it you're going to have people who eventually buy into it. But they can only bank off the get-rich stories of others, hoping if they are obedient long enough and give cheerfully they too can cash in on God's lottery. They are taught that doubt is tantamount to disobedience; and what's more, it is a requirement to give to the lottery commission under fear of a curse. Since most Christians do not truly understand the New Covenant, they are whisked away with the "tithe requirement" before they can investigate the matter themselves. They become prisoners of denominationalism grow up-think and are at once put to make bricks under Pharaoh's ten-percent taskmasters. They are then told this quota must never fall (even when the straw becomes sparse) or else God will allow the whip of the devourer to lash their backs.

My in-laws are big Pentecostal tithers. They are forever in debt, borrowing money till payday, and then when they default on the loan the creditors call my house (because they listed me and my wife as reference). I shudder to think they have to give the taskmaster his 10% cut after each loan and then spend the rest of the year trying to pay it back with high interest. They will not admit that tithing does not work though they have been in this sad financial cycle for over 13 years. I know other families (Southern Baptists) who have faithfully tithed for 35 years but still live from paycheck to paycheck and do not have ample savings to retire.

I once asked why this was to him (my co-worker), and he thought a moment and shrugged. "I've always been taught that tithing is just what you do. God requires His ten percent." And left it at that.

It is almost terrifying the degree which pastors bully the sheep into tithing these days. Now I understand, many of them have a gun to their own heads too. If they don't tithe, denominational officials (especially in Pentecostal churches), will remove you from ministry. And being that they don't have any other marketable job skill, some will truly tithe until it hurts. They know if they don't, their family will be out on the streets.

Being in the business that I am at the bank, I have attempted to make several itemized budgets for the average family of 4 to survive off, pay all their bills, and still make a 10% gross tithe payment. It has been my honest assessment that in America, the average family of 4 cannot afford to tithe if they make less than \$50,000 gross a year, and still pay all their bills

Of course, there are exceptions to this. But if the average family of 4 does manage to do this, they definitely will not be able to save much of anything on a monthly basis. They will live paycheck to paycheck. They will retire broke. If it were not for any hope of Social Security and other government entitlements, they would be left destitute once their ability to work expired.

The math simply does not work for most people. Most people truly cannot afford to tithe, in spite of people telling them they cannot afford to not tithe.

I've seen it. It is heart breaking. The prosperity gospel is robbing many saints.

But, we still have the rest of the money being spent on things in house.

Right out of the box, I am going to say this: I do not agree with the doctrine of tithing 10% of your income to the church. Why, because it isn't 10% of just your financial income. It is also 10% of your crops, and every 3 years that 10% is supposed to go help the poor of the land and the levite. If those who preach tithing really did get it from scripture, there would definitely be a lot more to it than just shaving 10% off the top of your paycheck (gross or net).

I also believe that the old testament law is fulfilled in Christ, and since we no longer have levites nor a temple, then what would our tithe, biblically be connected with.

Also, I am not so sure that failure stories is valid justification for the rejection of this doctrine. People who are generous with what they have (like the Bible says to be) yet do not operate their finances like the bible says to, cannot expect biblical results. Point in case: If I give half of what I make to my poorer brethren, but rack up enough debt to be enslaved for a lifetime, then I may have fulfilled what God has said in one area, but I have absolutely rejected what He said in another. Can I expect anything but discipline from the Lord for this? I think not.

I do believe that we are called to a different kind of stewardship. Nothing belongs to me, because I am a slave to Christ. He owns all my stuff, and as His slave, everything I have should be used for His name and His glory--for the advancement of His kingdom. Anything that cannot be used for that end should be tossed out.

I was a certified minister in the Assemblies of God when I began to have doubts about tithing. Of course, tithing is one of the non-negotiables if you want to retain your credentials in the denomination. Any suspicion that you are withholding your tithe brings you under the threat of dismissal.

One year I simply chose not to renew my credentials. This naturally brought a phone call from the district presbyter, but not after I received an embarrassing letter from the general council. The abridged version of the letter stated that as a mortician (my secular profession), the average salary was "x" amount of dollars per year according to national statistics. My current tithing record reflected my salary for that year was, in fact, far below the national average. They then asked me directly (by checking yes or no in a statement) if my tithing was an accurate calculation of 10% of what I in fact earned.

Of course, I was floored - and then just angry. I tried to imagine Paul or John sending such letters to the elders in the churches of Asia minor. It was obvious it was time for me to leave the AG. I still have the letter, by the way. I don't think I'll ever throw it out.

It is ok to let the Word of God speak.

And, it's not as if modern day men and practices are above leaning on the flesh and following men instead of Christ. But there is a price to pay for following men (not following God) and the Holy Spirit describes it very well in 1 Samuel.

Just as there were false kings of the sheepfold in the OT, there are false "kings" of the sheepfold in the NT.

What I find interesting in 1 Sam 8 is that even the Elders wanted a man to rule over them. They condemned Samuel's sons for their blatant money grubbing (bribery, extortion) but did not see their own sin and dependence on the people providing for their needs.

Same thing today. You have preachers (Elders) who run a pretty tight ship and every thing looks to be in order from a religious point of view and they condemn the blatant money preachers, not understanding that in their sophisticated and subtle way, they are "money preachers", too.

1 Samuel 8 is excellent for showing us two kinds of people that use religion (godliness) for gain. The unrespected, blatant, money grubbing preachers (Samuel's sons) and the subtle, sophisticated, respected preachers. They are all caught up in a system that refuses to have God as their complete and total KING. And of course they would tell you that is absolutely not true. But, like Paul West's experience, touch the money and you will see the real intents and motivations of the heart. And you might just find out like Paul and others on SI that you are persona non grata.

That's a pretty powerful story Paul. I remember when I was in the Church of God that the pastor of the church I was at announced that a directive had come down from Cleveland that the pastor was to ensure that all lay ministers were actually in fact tithing 10% to the rest of the church. Now, he went off the honor system, and didn't ask for audited financials or anything like that.

At the time I was a recent college graduate, making a mere 30 grand a year, but had just as much debt. I tried to keep up with tithing, as I knew it was a requirement for ministry in the church. Eventually I had to step aside because I could not afford to keep up my debt payments from college and pay my tithes. I gave what I could, but I simply could not afford to give anymore.

Had I not been dating/engaged to the youth pastor/worship leader, whose apartment I helped furnish and whose expenses I helped subsidize when I dated her on the weekends, I probably could have afforded to tithe. She tithed by the way, and when I was unable to do so anymore, shortly there after, it was one of the reasons she called our engagement off.

Prior to that I had been a candidate for being an elder in the church. After that, Bible college grad and all, they wouldn't even put my name on the roster to teach Sunday school. But my ex-future in-law, who was chronically unemployed and living off the government, tithed what he made from them, and who eventually lost his home, was put on the elder board and Sunday school teacher list.

Sometimes it appears you just got to "pay to play."

When I was going through the whole tithe conundrum in my denomination years ago, I remember sincerely asking God about the issue - because I just wanted to be obedient. It wasn't about the money, because my wife and I (a registered nurse and mortician) made more than enough money in our given professions to live comfortably. It was instead an issue of bondage, of legalism, of a faulty understanding of the New Covenant. Ever since I had come to the Lord, I was taught that to not tithe was an act of selfish disobedience and, even more - I was robbing God. A criminal act!

Going through each book of the New Testament revealed nothing about what I was being taught; instead all the verses were being extracted either from the Levitical law or the times of Abraham and Melchizedek which predated the law. I saw that circumcision, like the tithe, also predated the law, but whether or not circumcision was required was obvious thanks to Paul's treatise to the church of Galatia. The question still remained about the tithe.

And then God spoke to my heart one day and forever settled the matter for me. He told me that if I could read the New Testament of Jesus Christ in its entirety (from Matthew to Revelation) as an early Greek or African believer would have in the beginning, and come away with a propulsion to tithe (considering I even knew what tithing was), then, of course, I was to tithe as an act of faith. I've done the math... a family of 4 making \$50,000 a year or less probably cannot afford to tithe... contrary to preachers telling them "you can't afford not to tithe".

Many pastors have been known to boldly stand in the pulpit and proclaim, "You can't afford not to tithe!"

Many of these pastors have never sat down and tried to make a budget with the people they are preaching to. They've never sat down and done the math.

As I will demonstrate in this brief essay, the average family of 4 making \$50,000 a year probably cannot afford to tithe.

The financial assumptions I am making in this essay assumes a family of 4, where the husband is the sole wage earner in the family, and where the wife is a full-time stay at home mother who stays home to take care of the kids. I assume they own 1 car outright, and have an auto loan on another. I assume they have a mortgage that is reflective of 25% of their gross monthly income (which is pretty common). Because it is the law of the land, I am operating under the assumption the household is fully insured. I assume this family has no credit card, student loan, or medical debts. I assume this family

y is not making any contributions to retirement savings.

Since I personally live and work in the greater Charlotte, North Carolina area, I am going to assume taxes and living expenses that are in keeping with a person who lives in the suburbs of my living area. I work as a mortgage underwriter for a living, so some of my assumptions come from being regularly exposed to the personal finances of a lot of people, as well as the general lending standards of most banks. Please feel free to adjust these expenses based on where you live to see if what I say pans out.

Using the PaycheckCity.com calculator, I have determined that a married man living and working in North Carolina making a fixed salary of \$50,000 a year will gross \$961.54 a week before taxes/social security, and will net \$738.58 after. His gross monthly income ( $\$961.54 \times 52 / 12$ ) is \$4,166.67, and his monthly take home pay is \$3,200.51.

Monthly Gross: \$4,166.67

Monthly Net: \$3,200.51

Itemized expenses:

Tithe 10%: \$416.67

Mortgage payment: \$1,041.67

Groceries: \$850.00

Water Bill: \$50.00

Electric Bill: \$150.00

Gas bill: \$50.00

Home/Cell Phones: \$150.00

Clothing: \$50.00

Auto Loan: \$200.00

Auto Insurance: \$100.00

Auto Gas: \$100.00

Auto Maintenance (Tires/Oil/Taxes/Inspections): \$150

Health/dental/vision insurance: \$200.00

Miscellaneous: \$100.00

Total monthly expenses: \$3,608.34

Monthly budget deficit: -\$407.83

Based off these rough, and rather conservative monthly budget figures that I used, I have concluded that the average family of 4 living in the greater Charlotte, North Carolina area making \$50,000 a year simply cannot afford to tithe. Without their tithe, this family of 4 would be lucky to break even on a monthly basis. They don't even have room for regular monthly savings, let alone money to contribute to a retirement account.

In order to pay their tithe, this family would ultimately be forced to skip out on some other bills in order to make the math work, or they would be forced to radically downsize their current lifestyle... which is already pretty conservative.

So the next time a preacher tells you that you can't afford not to tithe, ask to sit down with them and work out a budget with you, and ask him how this math works. Because as far as I'm concerned, as somebody who crunches numbers for a living, I do not believe that the average family of 4 that is lower middle class and below can actually afford to tithe on a monthly basis, and still stick to their monthly budget.

That may seem like a rather high mortgage payment, but it is pretty typical for what banks lend. IMO, most people should try to get a mortgage that is no more than 20% of their gross monthly income. But banks will lend up to 36% in some instances. So, 25%, which is what I used in my example, is still pretty conservative.

And in the area where I live, you'll be hard pressed to buy a home for under \$1,000 a month for principal, interest, taxes, and insurance (fully escrowed). Most people I know are easily paying \$1200-\$2000 a month.

For anything below that, you'll have to move a pretty good ways out of the county, or live in a really run down part of town. But if you chose to do that, you'll easily see your monthly gas prices increased due to the increased drive. So you might be able to live in an older home for \$800 a month... but it'll cost you in other ways to do so.

The reality of life is that God is astoundingly good and sends His rain on the just and unjust, irrespective of how much they give sacrificially. If we exclusively go by money as the sign that God has "poured out His blessings" on a person, then we must concede that Muslims, Jews and Atheists hold the majority of wealth in this world - and therefore, must be the most favored by God.

Here is a quote by Dorothy Parker I just love: "If you want to know what God thinks of money, just look at the people he gives it to."

The crazy American gospel equates money and success with God's favor. If a person is particularly gifted in athletics, for example, the belief is that God's favor is on the person (especially if they give Him glory for their skills). But what goes unmentioned is a fellow Buddhist athlete is just as gifted and wins just as many medals and attributes his skills to meditation. The idea that God's favor is evident through carnal means - i.e. the ability to run faster, throw a football further, excel in business, earn lots of money, etc. is Old Covenant theology, where God increased flocks and crops and gave His "mighty men" athletic power to rip apart lions and bears.

Not so in the New Covenant. The apostles were not rich and athletically superior. They were weak, humble, despised. They did not preach tithing and "releasing the power of God" through some sacrificial action. That is a cheap, superficial misrepresentation of the gospel of Jesus Christ, which brings it down to the level of magic.

The truth is that God usually has to take everything away from us in order to break our reliance on the things the gentiles seek after. What you are saying sounds good and I am not sure I disagree with it.

But Jesus commanded that we go and "teach everything I have commanded you." The question we must then ask is, "Did Jesus teach us to give?"

If the answer is "yes" then we must teach about giving. I am not saying that we should ask people what they make and keep track of what they give. I am saying they should be taught about biblical stewardship.

That concept is found in the teachings of Jesus, that a person who follows Christ must forsake "all that he has" (Lk. 14:33/ Mt.13:44-46). The ceremonial law served as a precursor of this NT revelation. The latter teaches that all of God's people, having been "bought with a price," are not their own, but are owned entirely by Jesus Christ (1 Cor.6:19-20). ALL of the believer's time and ALL of his possessions belong to God.

The Christian is a "steward," or "manager," of somebody else's (God's) possessions. I agree that he is not in some partnership arrangement with God in which God holds 10% and he holds 90%. In coming to Christ, the repentant sinner surrenders EVERYTHING to God, and claims ownership of "nothing" (Acts 4:32). At conversion, the believer becomes responsible to manage every asset (monetary or otherwise) in the interests of the Master's profit. whoever seeks to reserve a share of their lives for themselves should not bother applying (Lk 9:23).

What must the steward do? He must discharge his responsibility in exactly the manner that his Master would do if He were in the steward's shoes. What would God spend His money on? The Scriptures give us plenty of guidance on this matter. Throughout Scripture, God expresses His concern for the helpless poor and the support of ministers of the Word of God. A gift to the poor is a gift to God Himself (Prov.19:17/Mt.25:37-40), and is the method of depositing treasures in heaven (Mk 10:21/Lk. 12:33). Giving to the needy is merely an expression of the mandate to love our neighbor as we love ourselves (Lk. 10:27-37).

We must also realize that God promises to meet the needs of His servants and their families. Therefore, a certain amount of our income must be devoted to the feeding, housing and clothing of our families (1 Tim.5:8). Nor is there any forbidding of a few things for enjoyment alone (1 Tim.6:17). How many such things? That is between the steward and his Master, and is not for another to judge (Rom.14:4). HOWEVER, we must guard against our own relentless tendency to judge our own actions (and expenditures) more favorably than the facts would suggest. In eternity, I believe that our joy will be in proportion to our self-denial in this life and our generosity to the poor and to the work of God.

In the first century after the apostles, Christians understood that tithing had been replaced by full surrender to God. In "Against Heresies," Irenaeus wrote, "they offered their tithes; but those who have received liberty set apart everything they have for the Lord's use, cheerfully and freely giving them, not as small things in hope of greater, but like that poor widow, who put her whole livelihood into the treasury of God." The Didache (early second century) states: "Do not hesitate to give, and do not give with a bad grace; for you will discover who He is that repays you. . .Do not turn your back on the needy, but share everything with your brother and call nothing your own."

I guess my whole point in all this is that when you look at what the Bible teaches about stewardship, tithing may be getting off cheap in comparison.

My first brush with tithing came early on in my walk and involved the pastor asking me not to ask for money from other believers to support a soup kitchen I had set up in the city of Leicester. Basically the pastor didn't want me to take the tithe but to clearly explain that any giving had to be separate. I agreed because I was tithing myself and felt that this was an acceptable thing to do. I understood that the tithe was used to pay for full time ministry as well as some missionary work.

Yet somewhere in my heart I had a conflict. One day a brother came to me and explained that he wanted to support the work financially but could only afford to give his tithe. I explained that the pastor had forbidden me to take the tithe and then added that if he wanted to give it I would take it anyway. A few weeks later I was held up in the church and had to explain myself. I was honest but quickly realised that my honesty was not going to help me very much. In the end I recognised that I had given Satan an opportunity and he took it with enthusiasm. The brother who wanted to help had in effect trapped me due to my own heart of believing that my work was more important than the pastors wages.

To this day I still don't have a problem with tithing per se, but do agree with TMK in that the alternative is to hold everything unto God and to be a good steward. I genuinely don't see anything wrong with the principle of tithing, but can see even

Nothing wrong with giving nothing. I suppose reality falls down where our hearts intend and so if we do not hear from God regarding giving to the poor as well as supporting those in full time ministry, then this is because we have no desire to give at all. What that means in the end I don't really know. I am sure that it is not an issue of life and therefore whatever it means it will be revealed in the coming kingdom.

No one should wrestle over money. The Lord is a debtor to no man. He will pay our wages if we really set our hearts on serving Him. If in that we go hungry or cold or our children cling to us, then it is because of the disobedience of men who are able to give and will not do so. It is interesting to note that in the four gospels you don't see any didactic demonstration of Jesus actually "giving" things (money, food, clothes) to the poor and needy - much less teaching his disciples how much and how often to give. It was always Him asking things from other people: "Give me a drink", he asked the woman at well. He sat and watched how much money people put into the treasury, but scripture is silent about how much He actually put in Himself. This is because mere money in the face of divinity is absurd in itself. Jesus gave the world far more than money. All the money in the universe couldn't bring the widow's son back from the dead, but Jesus did it for free. All the cold water in all the wells of Israel couldn't give Bartemaeus his eyesight, but Jesus gave it to him freely. Surely, we too should give. But how, where, when and how much must never be legislated. Jesus never legislated, Paul never legislated, John and James and Peter never legislated. They commended the believer into the hands of God to be led and taught by the Holy Spirit.

Brethren, we must appeal to the Holy Spirit alone when it comes to our giving, otherwise we just relegate ourselves to the auspices of benevolent humanism in the name of Christ. If we are mature Christians, we must be led by the Holy Spirit in all of our giving, and we must be discerning. Just because a missions organization exists, it doesn't mean we are to automatically pour money into it. Just because we see a panhandler on the street, it doesn't mean we automatically give him a twenty. Giving the prodigal son money when he was down and out would have been a horrible thing to do, and would have gone against God's plan to bring him back to his senses. Just because there are Koreans without Bibles, it doesn't automatically mean we are to buy one thousand dollars worth of Bibles and ship them off to Korea. As good and noble as these actions may be, we must wait to hear a personal directive from God. We must understand this principle.

Once God gives the directive, the giving will be cheerful, borne out of an obedient spirit. I have given to causes in the past without first discerning the heart of God, and the giving was never truly cheerful (though I tried to create an aura of cheerfulness in my spirit). I instead did it out of a sense of obligation, believing God would be pleased - I really wanted to please God. It was selfish at the core, for as long as I knew God was pleased with me, I could then be pleased with myself. Can you see it?

Giving specifically after God directs, however, is different. Spiritual joy floods your being. The focus is taken from self and instantly goes to God. The joy we experience now comes from the knowledge of our own unworth in being allowed the privilege to give, rather than the act of giving itself merited to the kindness of our own hearts (and in what we believe is our godly obligation). It's a very subtle shift, but one that makes all the difference. The difference between soulful giving and spiritual giving.

As far as the homeless go, having worked with them every week for several years of my life, I am always reminded of what one former homeless drug addict who got saved told me years ago:

He told me that he always gave to any beggar he came across since he cleaned up his act if he had the money. He said it is true that most of them, like him, are just going to take the money and spend it on booze and drugs. But he gave anyway, knowing like him that many are so addicted that it is a matter of life and death to them. Without their fix they could go into severe relapse and die. He often ended up in the hospital because of it. Knowing that he needed his drug fix so bad, he often would break into homes and such and steal stuff to support his habit.

Eventually though, God got a hold of him, and he got help, got his life together, got a job, married, and had kids and is now a grandfather. He said if his giving keeps one high street person out of somebody's home and out of the hospital and keeps them alive one more day, that is one more day they have the chance to get saved and get cleaned up. It is what happened with him.

That story has stuck with me for 12 years now. It has influenced why I do what I do when dealing with beggars. Most of the time when I know I am going downtown, I try to always get some pocket cash just in case the opportunity arises.

Yes I read what Mr West posted and I could easily reply to it with some substance and reality of experience. I won't for self evident reasons. I have to say I am sickened by what I am reading here but ought not to be surprised. What I have written is not a matter of thinking I understand what it means to be led of the Spirit in the matter of giving to the poor, it is based on experience in my own body. I have been ripped off more times than I can remember. In most instances I am happy to be defrauded because I too was once a thief, and therefore know what it means to both steal and to give. There is a spirit I find that is very common not only in pulpits but on street corners. It is a spirit that understands something about the human condition and how most people through guilt and condemnation are easy targets and can be preyed upon.

This is actually very appropriate for the tithing thread, because this is what many preachers do. They prey upon their own people, in a sophisticated way of course. They have many ways (and creative sermons) to satisfy their greed and covetousness, but always through subtle messages of guilt and condemnation accusing others of lack of compassion or having too much. And it works most every Sunday. They also know that people will feel better if they have a cause to give to, so why shouldn't they be the ones that are that "cause"?

To use God for personal, greedy gain is most outrageous and the church world does it openly (on TV) before a lost world. Many beggars or panhandlers have caught on and are now using God just like the false, greedy preacher man.

Are there some panhandlers that are in true need? Yes, of course, undoubtedly so. I also know preachers that don't require a tithe or salary and truly live by faith. Not all beggars are on the take, preying on people and there are a few preachers who are not preying on people, either.

Finally, no Christian has to prove to any other man (let alone a fellow Christian) that they are compassionate. Again, for those getting upset. The issue we are discussing is indiscriminate giving (under which the tithe falls). This is much different from being miserly. It is important to note Jesus did not cleanse entire leper colonies. He did not revive entire cemeteries. Such impulses might be steeped in the logic of humanism, but they are not God's way. The money I have is God's - not merely the tithe, but 100%. That means none of it is mine to spend autonomously.

Knowing this, I want to try my best to spend it according to his heart, according to His will and purpose. This means that if I am not prompted to give His money to a certain panhandler, I won't - no matter what the sign he is holding says. There may be another beggar I see tomorrow to which the Holy Spirit says "Give to him", and so I give. It's God's money; He should choose to whom it goes. We need to be able to discern His heart in this matter, otherwise we will give to anything and everything that puts on a sad face and panders to the emotion: tantamount to clearing out entire leper colonies for the sake of goodwill.

God has given us the freedom to hear his voice and be led by Him in all of our giving and taking. The old way was to go to a prophet or some human oracle to get instruction. To get rules, legislature, commands on what to do, how to do it, how much, etc. The flip side is to go off our own corrupt humanistic reasoning; of what "seems" right, of what we believe our godly obligation is, and of what others tell us we need to do. What has my own experience got to do with addressing this topic. If I make a personal comment it is to back a statement. Such as saying that I have generally found believers to be hard hearted and lacking in compassion for homeless people. Or perhaps even more generally as well. It is a sad fact, and being thus said it amounts to saying no more than that which I have experienced myself and witnessed many times. This is not only a personal comment but a more general comment. You don't have to keep feeling sorry for me as a way of excusing your own failings Just-In or making reference to my past or being concerned about it. I am more blessed than many in every way.

As a family we are multi millionaires. We live in an Edwardian nine bed mansion. Drive Mercedes Benz vehicles and have more liquidity than we could possibly spend. Lets get something straight Just\_In. I haven't known hunger or a lack of comfort from the day I believed into Christ to this hour. Before that I slept on park benches, floors of warehouses, and in the street. Other than that I spent the rest of my time in prison. I can make the distinction between poverty and wealth directly. I can also see what an astonishing difference there is in the way believers deal with you when a poor man and wh

en a wealthy man. I utterly detest it without reservation.

This thread is about how we tithe or more generally how we give to others.

Your own comments were in my opinion typical of the kind of remarks which I hear constantly from believers who for the most part have little to give. The only difference is that I can look them in the eye and they turn away because they do not understand how a wealthy man can hold an attitude which stands at odds with their hypocrisy of judging the hearts of others and understanding why people get into the mess which makes their lives such a misery. There is no compulsion to give what you do not have. If you have much then even a poor man can exceed you in giving by giving all of his little substance. Praise God for that. It is not about wealth or poverty. It is about the heart of compassion for the Lord's sake.

Mr West made what appears to have been an attempt to raise the bar a little and put the thing into a higher plane. Several have acknowledged that this presentation is helpful and meaningful to them. Mr West asserted that a person can be harmed or hindered by help.

When my son who has never known a moment of discomfort or hardship and who has more money than many adults have, decided to rebel one time I took him to the edge of reality in an instant. I explained what it actually was like to be homeless, cold and alone. He was very nearly sick and turned back instantly. The parable of the prodigal son, is not for rich brats who throw away their parents efforts, it is for all men, and has to do with seeking out the Father in heaven. If applied to a financial matter it takes on the meaning as was applied. I happen to think that this is wrong and fundamentally other than the intended and true meaning of the parable. If our giving exceeds that which is necessary for the basics in life then it may well be a reasonable and necessary thing to discern at least the wisdom of giving more than a man needs for his life.

The Christian life on the other hand is not a psychological exercise where people have to reach the bottom before they can be brought back. You can go out in Christ name and bring them back by authority. If not then with tears!

I am simply saying to you that suffering and ease are of themselves not the issue. The issue is compassion. The rich perish and the poor may well believe more easily but they too perish. Your own comments about me are getting thin Just-In. Why do you feel a need to reply if you are so confident that your elitist and individualistic understanding is so right? If a brother came to me and asked for ten thousand pounds then I would see a need to exercise some proper discernment. But if a pastor needs his keep because he is in full time ministry, or a brother or sister needs a bed, some warm clothes and some food then it seems to me that I am obligated before God to give it if I have the means to do so even to the end of wealth.

I actually believe that in the end it will come down to that very thing. Then the whole matter will be settled of necessity. The Amalekites who preyed on the rear of the flock of Israel continued to be a prey until they were eventually destroyed some 700 years later. Are you saying that someone who presses for a tithe and teaches that it is a true and proper way of measuring to the kingdom, is an Amalakite preying on the flock? If we so easily reject men out of hand because they perpetuate the pastoral ministry improperly then we will no doubt find it easy to believe that we have not spoken against the Lord house. I do not so easily reject any man as being an unbeliever and so I am willing to bear with most men. Even though I may go against them directly I would not so easily say that they are unbelievers if they in fact do believe into Christ Jesus according to the doctrines of life.

So on the basis of saying that you know of men who press strong doctrines onto the flock, there is no basis for formal giving and no basis for bearing responsibility of others needs unless you have an express leading of the Holy Spirit. In the end this thread has concluded for the most part that believers should only give as the Holy Spirit leads them. I cannot see how that could even be possible. We are not inert flesh. We comprehend need and so if we are not willing to meet that need we know that also. Waiting to be led of the Holy Spirit may well be a necessity in some circumstances. As far as I know the so-called mandatory tithe is fully intended to be a tithe to the house of the Lord. I agree that it is not in evidence in the apostolic church. What I cannot agree with is that it is arbitrary or that it is fundamentally wrong to the point of becoming a curse. As noone said the problem really lays in the way we understand church life itself. Yet even in this regard we forget that it has pleased the Lord to bless and support this pattern of church life where a single pastor holds broad ministry responsibility. Many profoundly godly men have held that part and done great things for the Lord Jesus both in numbers of men into the kingdom and in setting a good example to the flock.

If today there is a need to re-look at this pattern then perhaps it is because there is a more significant change afoot which makes that pattern of ministry redundant. That change may simply be persecution. Supporting a godly brother and his family is a privilege even when the pattern is wrong for this day in which we live. Yet even a small flock of fifty believers could easily support such a pastor elder in the basics of life and then the pattern is only changed in so far as the issue of unnecessary wealth is removed. It may well be the responsibility of a minister to walk by faith, and that could easily mean having some practical work to earn a basic living. It may also be that there should be several such men leading the ministry and serving others to play their part also.

Feeding the poor brethren regardless as to how they come into their need will never be removed, nor will the pattern of ministry remove it unless every member works with their hands to make a living apart from the gift which they represent to the church. From what I have read in recent years and the many conversation I have had it seems to me that there are a number of clear moves afoot which are shaping the minds of brethren in how they think about the whole question of the church as a body of believers. Some of these appear to me to be in agreement with the reality of preparedness for coming persecution, but others appear to be false in that they are moves which are seeking to remove any notion of the pastoral ministry itself.

Tithing of itself cannot be evil. And no matter that some brethren take a wrong comfort from it and others wrongly ask for it, these things will not change the outcome of a faithful walk. The Lord is not asking us to be perfect in detail, we are asked to be perfect in obedience. In that sense all contentions are settled because a man simply has to obey his conscience and the leading of the Holy Spirit to be perfected. I have never fully agreed with tithing yet I did tithe when I was a young believer and the Lord never once said to me to stop from doing it. In the end I only changed my mind because I realized that this tithe has made ruin of many pastors because it ends up far in excess of what is necessary for life. Even in this regard the Lord has never told me to begin again.

Watchman Nee sought to put this idea of pastoral ministry into an experiential reality in China in the 1920s and 30s. The pastor's in that exercise became the bishops or elders and the ministerial pastor of Ephesians five became essentially a co-worker going out into the mission field with other co-workers. In 1948 Nee held co-workers meeting in Gu Ling and began by addressing the reality of what happened to these co-workers in the ten years of their experience. Many starved to death, some died of cold and so on. It was at this time that Nee shared a vision regarding the necessity of all believers pooling their wealth freely so that this wealth could be used to support all the co-workers as they had need.

Even this Jerusalem Principle, as it has been called by some, amounts to a legalistic formality if the one who partakes in it does so for reasons of selfishness and pride. How will we remove from that possibility? We cannot remove from it bec

ause these things are of the heart and no man has dominion over another man's heart. In the end brethren will do what they will do of their own volition and according to their own intentions. The cost to other believers may well be considerable. There is no possibility of the kind of freedom which brethren speak of happening in the way we would like it to happen. There will always be believers who take and will not give. There will be believers who give and have no need to take yet become proud and self justified through their gift. There is no right or wrong answer because in the end it is a heart matter.

There is no way to change this attitude even if we did away with the tithe altogether unless the Lord Himself judges His house. In Jerusalem where the kingdom was increasing daily with peace, at the time of the apostles, Ananias and Sapphira were judged unto death. Yet the sin was not in giving, nor was it a not giving, it was lying against the Holy Spirit. The outward action was withholding a measure of their intended gift having sold a spare property to support the Lord's work. The inward action was to conceive a lie to cover their change of mind. And Peter asked the question 'why has Satan put this thought into your hearts?'

“But Peter said, “Ananias, why has Satan filled your heart to lie to the Holy Spirit and to keep back some of the price of the land? While it remained unsold, did it not remain your own? And after it was sold, was it not under your control? Why is it that you have conceived this deed in your heart? You have not lied to men but to God.” And as he heard these words, Ananias fell down and breathed his last; and great fear came over all who heard of it. (Acts 5:3-5, NASB95)

I wonder how this admonishment of Peter stacks up to the claim that everything we own belongs to the Lord. If we intend it to be so then it may well be so. But if we say we intend it there is coming a day when we will be judged by that intention.

“While it remained unsold, did it not remain your own? And after it was sold, was it not under your control?”

Possessions appear to have a different meaning to money itself. One is clearly ownership the other is stewardship. The tithe it seems to me falls into the category of stewardship. What that means in the end will be a matter for the Lord Himself. Yet that we have control over our own finances is clear. Control always means authority. So I cannot help but believe that if a man chooses to give ten percent and keeps hold of the ninety percent he will be rewarded according to the ten percent and have to give an account for the ninety percent. The implication which Peter is making appears to be examine

your heart and be honest about what you intend.

First, it is important to note that Peter did not mention tithing at all. In fact, he said that after the land was sold the money was still their own and in their control, just as it was before they sold it. That is quite different than telling them that they were required by the Lord to pay 10 percent but that 90 percent that remained was in their control. He did not say, "now that your asset has been converted to cash, you are required to pay 10%." No mention of that at all.

If Peter had the concept of tithing that the church today has, (which is nothing at all similar to the Old Testament concept of Tithes and Offerings), Peter would have taken the opportunity to say something like this:

"Ananias, why have you lied about how much of the proceeds you are giving? After all, God only requires you to give ten percent. Anything above ten percent is a "freewill offering" to the Lord and you may do with it as the Spirit leads"

But again, any reference to tithing is obviously missing. Again, the NT is silent about tithing. This would have been a perfect spot to teach that Christians are under obligation to pay the tithe. But it isn't here. In fact, it isn't anywhere!

THE LAW OF TITHING IS NEVER TAUGHT IN THE NEW TESTAMENT.

I fail to see any PAYMENT SYSTEM that we are under in the NT.

It doesn't even make spiritual sense for a Christian to keep track of how much money they give to others, or how many chickens, or lambs, or bowls of soup, or pieces of clothing, etc. etc.

No system has been instituted in the NT and since men love to systematize and codify everything (even God), then it must be said that there is no PAYMENT SYSTEM in the NT. I am saying this only because of the weakness of man, we have a GIVING SYSTEM. I even have a hard time writing that, because God and matters of the heart cannot be systematized. But that is what religious man loves to do. We have vast libraries of Systematic Theology, which teach on many aspects of the PAYMENT SYSTEM. I would say the "Storehouse theology" in Malachi is probably the hub of the Evangelical Payment System theology.

I was told one time that the "storehouse" is the local church and you cannot give that portion to anyone else.

In the ages of grace and faith, God has commanded the church to give sacrificially and nothing about keeping a running ledger about how much you give and who you give to.

A payment system presupposes you OWE someone a DEBT. And yet, we are told to "owe no man anything but love". Payments are a requirement, Love is a gift. A gift is something that you give that you didn't have to give. It is not given because you must. It is not given out of necessity. It is not given under compulsion. Otherwise, it would not be a gift. It would be a payment.

2Cor 8:1 Moreover, brethren, we do you to wit of the grace of God bestowed on the churches of Macedonia;

2Cor 8:2 How that in a great trial of affliction the abundance of their joy and their deep poverty abounded unto the riches of their liberality.

2Cor 8:3 For to their power, I bear record, yea, and beyond their power THEY WERE WILLING OF THEMSELVES;

2Cor 9:7 Every man according as he purposeth in his heart, so let him give; not grudgingly, or of necessity: for God loveth a cheerful giver.

God no longer wants His children to pay under compulsion, but to give cheerfully. It is impossible for the requirement of paying the tithe to remain if God says that our giving is not under compulsion. If you owe it, you are under compulsion to pay it. The very act of paying tithes creates an act of "necessity" and 2 Cor 9:7, says "not grudgingly, or of necessity".

"But shouldn't tithing be the starting place? Shouldn't it be the minimum?"

That would be like saying, "Shouldn't circumcision be the starting place?" "Shouldn't circumcision be the minimum?"

I think if this were true, the New Testament would have stated it, somewhere, just once.

The requirement of tithing has kept God's people in slavery to the Law and has kept them from growing in God's grace.

How can you grow in grace when you are bound to a legalism by others? Because, the Lord is certainly not binding us to a legalism of payments. We cannot accuse Him of putting this on us.

More importantly and what has not been explored yet, is that the legalistic teaching of tithing has opened doors to other legalisms in the church and that is why God's people cannot grow in grace towards one another. They are being compelled and required to "love". Is that just a crazy concept or what? It's like a person who is forced to live under Communism/ Fascism for most of their lifetime and then freedom comes. They still by rote, go through the same motions everyday. They don't know what to do, or how to handle freedom. They still show up each day in line for their daily bread rations, they still "spy" on their neighbors as a good comrade looking for suspicious activity, they still parrot the party line when speaking to others not knowing what it means to be able to think and speak from a position of freedom of conscience. They have been bound by legalism for so long they even find security in their old way of life. It takes a drastic action to wake them up.

In short, people need a revelation to see that the Christian life is 100% about giving of all we are and all we have (according to 2 Cor 9:7) and not keep a running tabulation or record about your giving and not worrying about getting a tax deduction, and the Christian life is ZERO PERCENT about compulsion or requirements, or rules and regulations and yes, even the payment systems which we love so much and find security in.

Why is it so hard for people born of the Spirit to understand these things?

This is an interesting point you've brought up. I lived in the former Soviet Union from 1991-1996. This was right after the Iron Curtain fell, right after Gorbachev stepped down and Yeltsin took over. Democracy was new for the Russians; busin  
esses could now be privatized, including banks. As result of this liberty, violent organized crime groups suddenly came i  
nto existence. The streets Moscow resembled Chicago during the Al Capone prohibition era of the 1920s and 30s. Bank  
s were robbed almost daily, mafia hits at traffic lights, extortion, racketeering, kidnappings of company CEOs, etc. The o  
ppportunity to suddenly make unlimited money in this system of embryonic-capitalism brought open violence. Liberated fr  
om communism, the the poor Russians now found themsevles prey to the overwhelming corruption of a huge mafia-run  
syndicate eager to take advantage of their new freedom.

Many people expressed how it had been safer to live under the dicates of communism. Some even wished Josef Stalin  
were back. They would rather deal with the predictable confines of communism than with the unpredictable violence the  
free market engendered.

When people are set free from the law (i.e. the communistic law of Moses which demanded uniform conformity) by the S  
on of God, like those Russians, they suddenly find themselves in a quandary. They don't know how to handle their new f  
reedom. Some people, like the pharisees Paul mentions in Galatians, actually become indignant when they see a perso  
n walking in spiritual freedom and seek to put the person back under bondage. They imagine that Christian "freedom" re  
ally can't mean total freedom. There still must be some communistic do's and don'ts: "Do tithe. Do not drink alcohol. Do  
not dance. Do Sabbath. Do pray 3 hours per day. Do not cosmetics. Do not jewelry. Do not TV. Do read 10 chapters of  
Bible per day. Do not wear pants if female, etc."

These are just some of the more popular "Christian community" rules that are often imposed upon believers in their free  
dom. They are imposed because they are regarded as "safe", to protect against the potential threat of lasciviousness tha  
t comes with the freedom grace brings. Some of those guidelines are good, and I observe them myself. But I observe th  
em because I am led by God to observe them and not coerced by man. This is the fulcrum. We are free to give, but we a  
re also free not to give if the giving is not purposed in our hearts.

This angers people. It angers them because they see the atrocities that occur when people take advantage of God's gra  
ce, and this I can understand. Where they go wrong, however, is in the endeavoring to merge elements of spiritual com  
munism with grace to try to keep the sheep in tow. Again, the sheep are free. Totally, utterly free. But this freedom is inte  
nded to bring them under the law of grace where the Chief Shepherd can take over. If the Chief Shepherd says "Give", t  
hey give. If the Chief Shepherd says "Withhold", they withhold. If the Chief Shepherd says, "Go", they go. No man under  
the New Covenant has the right to usurp the role of the Chief Shepherd in issuing these directives in a spiritually commu  
nistic setting. As soon as he does this, grace vanishes and the old spoonfed regime of Josef Stalin returns.

Excellent point. All of God's "proofs" are consummated in the advent of Jesus Christ. All the validity a man can seek, the brokerage of every one of His promises in the OT, and the immortal assurance of His love and compassion for mankind are all encapsulated in Jesus Christ and in our spiritual marriage to Him. From this single union God grants us all we need. It is not right therefore to adapt a mindset that although I am in Jesus Christ, God is still somehow obligated to prove something more - especially when this proof is needing to be evidenced in the form of mammon.

Jesus said, "I am the way, the truth, the life". He is Abundant Life - we all know this abundance is not only comprised of food and clothes and money, but much more: the very life of the Godhead in our spirits. The real treasure is not mere money (brought on by the proof necessitated by tithing, as some teach), but rather the Life of Jesus Christ in man.

The problem is that not many people have fully evaluated this Supreme Treasure. This is because the treasure of Christ

does not translate over into abundant tangible means the way we have been accustomed to desire. God only giving us what we need in materialistic terms is banal and undesirable for most. People want to go above and beyond: they want the \$350,000 home in the gated community, the luxury car, the top notch schools for their kids, six-figure salaries, instant freedom from debt - and are trained to expect all this from God as a proof of His "exceeding abundance" activated from the tithe, totally missing out on the true Pearl of Great Price in exchange for hunk of fake glass.

It's all a facade. Life is fleeting, riches are inconsolable, beauty goes. The pretty glass gets scratched with wear and tear over the years...and the soul of man is forever gaping and hungry for more glass, like a bottomless pit. During these crisis moments, is God still saying to man "Prove me through the tithe?" No, He is not. God says instead: "This is my Son in whom I am well pleased." Jesus then says, "Come to me, all you who are weary." Weary of not having enough money? Why come to Jesus. You can simply go to the laws of karma and give what's left in your bank account to a beggar, and magically you will get more money. This is a universal law, like gravity. It works for Buddhists, Muslims, Atheists - what goes around comes around.

Again, Jesus says "All you who are weary, come to Me." Weary of ill health? (Note, money and health are the main things all the gentiles in the world go after, whether they be atheistic or religious). You can get healed without Jesus; you can go to a psychosomatic healer and get healed by the power of the soul. Muslims and Baha'i and Mormons have just as many "healing miracle" testimonies as do Christians in their faiths. And they attribute it all to their gods. Indeed, the True God of Israel healed infirmities and gave monetary riches and saved souls from hell (and even forgave sin!) for thousands of years under the Old Covenant, way before Jesus even went to the cross (see Psalms 103), yet many Christians still have this incorrect notion that God is waiting for them to "prove Him" in these areas via Christ, via the tithe.

Exactly! In the light of the suffering, death and resurrection of Jesus, and now the deposit of His Spirit, what else are we saying He should prove to us?

Going to Paul's point, "For all the promises of God in him are yea, and in him Amen, unto the glory of God by us." (2Co\_1:20)

There is no such theology in the NT about proving God, who has proven His love for us and in fact, is our great High Priest, who is making intercession for us daily.

"Wherefore he is able also to save them to the uttermost that come unto God by him, seeing he ever liveth to make intercession for them." (Heb 7:25)

Did Christ, being faithful to His Father, prove His Father's faithfulness to Him? Absolutely! We are to allow the character of God to be expressed through us. "As He was in the world, so are we".

We are actually to prove our love for Him, not Him proving His love for us. He has already done that. Loving others is an expression of God's loving character. And we are now the ones to give (as He gave). Christian giving is an expression of God's giving character which has been given to us by the presence of the Spirit of Christ, the presence of Jesus indwelling the Christian.

The whole Christian life is a life of giving, but we have categorized and cordoned off when and where and to whom Christians are to give. In reality, the religious world does not reflect the giving heart of God as they are more consumed with taking and making sure THEY GET their 10%.

Religious administrators and clergy are more like the government telling people when and to whom they should give and how much. Like the government, they would have no power, lest the people give it to them. That's what the religious world looks like, but that is not what the Church of Jesus Christ looks like. Well meaning godly people have ignorantly adopted worldly, religious practices.

Blessed be the God and Father of our Lord Jesus Christ, who has blessed us with every spiritual blessing in the heavenly places in Christ (Ephesians 1:3 NASB)

Have you ever been told that in order to experience God's blessings in your life that you need to do x, y, and z? Does any of the following sound familiar...

If you want to be blessed financially, you need to tithe.

If you want to experience a special touch from God, then you just need to go to listen to so-and-so preach.

If you want to be a super strong Christian full of the Holy Spirit, then you just need to pray 2 hours a day, read 3 chapters of your Bible daily, and regularly fast.

If you want to have a successful ministry, you need to trust God with God sized dreams.

If you want to be freed from sins you habitually struggle with, then you need to go and get deliverance.

If you want to experience peace and joy, then simply do these 10 things.

If you only do ... then only will you have...

The truth of the matter is that all of these things are terrible lies.

The truth of the matter is that everything you could ever possibly need you have already been given and blessed with by Jesus Christ. Re-read Ephesians 1:3 cited above. How does it read to you? Does it say you need to do anything to be blessed? Or does it say you ALREADY ARE blessed?

Here is a truth that regularly escapes us: Everything you could possibly need to do in order to be blessed was already done for you by Jesus Christ in His work on the cross.

There remains nothing left for you to do, other than to walk in and enjoy the blessings God has already richly supplied as a kind of act of grace.

You see, the Bible teaches that when Jesus Christ was crucified, resurrected, and ascended into heaven, that you and I were spiritually made participants with Him during everything He experienced.

When Jesus was crucified, we died with Him on the cross.

When Jesus was resurrected from the dead, we were made to live.

When Jesus Christ ascended into heaven to sit at the right hand of God the Father, we too were raised with Him into heavenly places, and are made to presently enjoy all the blessings He currently enjoys as the One who lives forever.

In recent essays I have given considerable attention to the modern day practice of tithing. And I have done so, not because it is some sort of pet issue of mine that I enjoy giving considerable attention to. I've only done so because I believe this particular issue exposes a deeper problem within the church, and magnifies a set of problems that reveal our true spiritual condition, and how immature we truly are.

You see, almost all teaching you will ever hear on tithing from the pulpit these days tells us that the reason we aren't experiencing everything God has for us is because we aren't trusting Him with our finances. If only we would tithe, then the windows of heaven would be open, and we would be blessed financially. If only we would tithe, we would get a promotio

n at work and be able to pay off all of our bills, and experience God's 100 fold blessing.

The days of "if only we would..." are over because of what Jesus Christ has already done.

The truth is that as Christians we don't give in order that the Lord might bless us financially. We give because we are already blessed.

We are already blessed financially because of our union with Jesus Christ, as we sit with Him and enjoy the same life He enjoys sitting in heaven at the right hand of God the Father. We don't need to go chasing down some 100 fold blessing. We have already been blessed 100 times over, and with everything beyond what we could think or ask. We lack nothing.

Therefore, we as Christians give, and do so abundantly, not from our arms being twisted by a preacher employing coercion and guilt tripping us, or fear of "the devourer" unleashing hell in our lives and somehow causing us to be ruined as a result, but we give out of the realization that we've already been blessed financially, and that it is the joy of our heart to do so.

We bless others financially because we have discovered that we are already blessed, and want others to enter into the same joy that we have in the knowledge of Christ.

We don't give in order to tap into God's open heaven. For the doors of heaven have already been thrown open for us when the King of Glory took His place in heaven, and He has invited us to come in and participate with Him in the blessings of that heavenly kingdom.

The only thing that remains for us to do is to open our eyes to see what has already been given to us, to see our true position in Christ, to see the riches that have already been supplied to us, and to live out our lives making the most out of what He has already done and what He has already provided.

Realising that this will sound contradictory and possibly even argumentative I post with some unease. Nevertheless I must post.

I rejected the Wealth, Health and Prosperity gospel some thirty years ago on first hearing it. It was so obviously false that I couldn't even bring myself to try to understand any part of it at all. Today I feel no different, and still speak against this false gospel whenever I have need to do so, for the sake of others.

When I was saved I knew from the very first moment, by an exceptional act of the Father's grace, that I was seated in Christ Jesus at His right hand.

Having asked the question 'who is Christ' I was translated into heaven and found that I was sat on the Lord's knee. Nothing more clear and unshakable could have happened to me which could have taught me something of a wonderful reality which seems to elude so many believers.

In this thread this reality is being spoken of. Yet the experience of the overwhelming majority of believers I have met has been to find no corresponding reality in their lives with the true knowledge, that in Christ we are complete and in Him we are supplied with the fullness of the rich mercy and blessings of the Father.

The worse thing for me over the past thirty years has been listening to fellow believers speaking about this wonderful truth and yet never knowing much of its reality in their lives. I have looked brothers in the eyes and seen that they were groa



ning under a weight and burden of difficulties, finically and in other ways, and asking themselves, 'when will my day come?' Many times I have sought to relieve such brethren and have done so with a willing and fearful heart realising that in some profound way they were missing the very reality which they knew ought to be theirs. It has at times been impossible for me to repeat that which they already understood with their minds and yet did not know in their spiritual minds so as to walk in it. Their faces are etched in my mind and the knowledge of their faithfulness, in that which they had received at the hands of their brethren, still makes me indignant.

For this reason I can say without intending any offence that I am myself offended for all those believers I know who suffer and pain through the inexplicable gap between what they have been taught concerning the fullness of salvation and laying hold of Christ Himself, and their own living experience of being defrauded by their brethren who take from them even the little they have. Many believers are used and abused by even the least of the brethren and yet when these things are taken up in a cry, even the one who is being used becomes offended because they simply cannot imagine their lives without their brethren. So they suffer the offence. When I speak with them in the momentary silence of the finger of God, their countenance speaks of injustice and they cannot fathom it at all.

When a truth is presented so decisively as it is in this thread, yet which for the overwhelming majority of believers, is simply unknown in experience of their lives, the effect is not liberty it is a weight of confusion and added doubt. Not only this, but when this liberty is pressed because it is out of place, the thing becomes a single word 'REST'. None of which is a falsehood of itself, but I say that it is a stumbling stone. The revelation that we are in Christ Jesus seated at the right hand of the Father, and that in Him we have all things which pertain to life and godliness, is both true and it means to enter His rest. It is to cease from ones own labours and it is to know the unimaginable goodness and mercy of the Father in Christ Jesus in your daily life. But simply saying these things is of no true value.

I have no way at all to explain how it is that some do enter into this rest and why so many others, even the overwhelming others, do not come to it. What I can say is that if in order to deal with the offence of tithing, which is of little consequence altogether, even though by compulsion it is an offence, we offend against that which speaks of the very substance of eternity itself. In doing this we will have made offence more important than eternal life. So many times over the years I have asked the Lord how it is that He continues to bless my life and the lives of those I have responsibility over, and each time I realise that it is because of Christ Himself and for no other reason at all. I have fallen and sinned, boasted in the flesh, wrestled with authorities at times and missed doing even the little things often. Yet the Father continues to bless and to pour out His blessing.

What is the relationship between such blessings and the source of those blessings? I believe it is just as simple as seeing the source, even Christ. That desire to know Him and to truly know Him overwhelms every other desire when it is met with the merciful hand of the Father.

This is a terrible thing and a weight and burden to say it.

We must be of such a mind that we truly comprehend that unless the Father Himself leads you, you cannot know Christ in this way of resting in Him. When the Father filled my understanding with the knowledge of His presence in 1984 I was kicking against His Son and openly declaring that hate was more potent and desirable than love. I wrote it down in words and I shouted it from my anger and hatred of that which was good, for no other reason than because I was hated myself.

I asked the Father in 1984 'who is Christ?' Now I ask was this faith? It was not yet faith to believe into Him. It was the mercy of the Father. Then after some hours I knew Christ in visibility and touch. If any man were to ask me today what must I do? I would say cry out to the Father, call upon Him and ask Him to fill you with the Holy Ghost, not for power to bear witness of Christ, but for revelation that you might know His Son Christ Jesus as He is. Rest is that which follows on. But to speak of the rest which is in Christ Jesus and to do so in terms of wrestling with the offences of men will prove to be of no benefit whatsoever. Even if we removed all the offences of men, we would still not know Christ as He is. There is nothing that men can do to make good the lack of faith and the evil desires of the heart. Whether the Father sets you free or ties you down is a matter for the Father and when you know it, of His hand in the rest which is in His Son, there will be no distinction of meaning, because it will all be a true resting from your own labours.

In finality unless the work of the Father in our lives produces true compassion we will ourselves make ruin of everything. That means compassion for the one who is defrauded and compassion for the one who defrauds.

May the Father help that man who makes of this a mystery and thereby puts it beyond the reach of men! May the Father

rebuke that man who makes of this an offence and thereby makes of this a ruination!
