It is a dilemma for sure and one that very few of us have ever had to face in this country. I find the ruling of the judge quite interesting, here is what he said:

"The room was quiet as the judge spoke for some time to an attentive audience- first about the seriousness and sadness of the offense, but then also about his respect and admiration for Ken's faith and character. He said he does not feel Ken is being sentenced for his religion, but for actions contrary to the law. As one whose responsibility it is to uphold the laws and to protect the system of law in this country, he also finds himself in a dilemma. Many people commit crimes in the name of religion (even murder), and if we discard the criminal justice system because of everyone's personal beliefs, we will have anarchy- a country without laws. He finds it painful and hard, but this court must enforce the law which exists."

It is such a complicated matter and I understand the judges sentiments. What is at issue is the horrible laws of man that are in effect, that a lesbian woman can even contend for a moment that she shares that child with Lisa? Insanity. The whole mess is satanic and an attack on Gods people, that much I am certain of. Look for much, much more of this down the road!

One other thing I read was that Ken was asked if he would do it all over again...aid in the kidnapping of a child. He gave a truthful answer but it was vague and worrisome for the judge which probably is what caused him to be given the maximum sentence of 27mths. In the eyes of the law they are concerned about repeat offences.

Regarding Corrie Ten Boom, I don't think this situation rises to that level brother. The Jews were being exterminated. In this case, we are dealing with child custody laws. And laws and situations that are not too uncommon. All sorts of people for all sorts of reasons want to get out of sharing their children with an ex-spouse. What are the courts to do...be partial?

Would it be fair for a non-christian to kidnap their child because they did not want to share it with a "crazy/extreme christian" spouse?

Certainly a dilemma if you are a christian judge thats for sure.

So what about Lisa Miller? Should she remain a fugitive? If she ever returned she would probably face harsh justice and the child would suffer as a result and probably never be returned to her. That is all conjecture on my part but I am sure she is thinking these things as well. And she is still being hunted, actively pursued by the US authorities.

More than anything I feel for this woman and her child...may the Lord continue to protect and guide her!

Brother the Supreme Court has ruled that marriage is now between a man and a man and a woman and a woman. This is the law of the land. This is the law that has to be obeyed. This is a law that is now on the books.

So you are an evangelical pastor who believes that marriage is between a man and a woman. A same-sex couple come to you for marriage. Can you obey the above law and perform a sanctified marriage for a same-sex couple. Can you obey the above law with a clear conscience. Particularly when the law of God is that marriage is between a man and a woman. Brother just because something is on the books and it is called federal law. Does not mean that the law is just in the eyes of God. Particularly in the case of two of the same sex who wish to be married.

Let us say that you are a Christian wedding caterer. You take a sanctified view of marriage as between a man and a woman. Your job is to provide services for weddings. Up until now your clients have been heterosexual couples. All of a sudden a same sex couple approaches you for services for a same sex wedding. Can you with a clear conscience provide those services knowing that God's word teaches that marriage is between a man and a woman? Yet federal law says you cannot discriminate against this couple.

Let us say that you run a Christian adoption agency. Your desire is to place children in a loving Christian home. That is a home where the parents are a man and a woman. All of a sudden you are approached by a same-sex couple who profess to be Christians who want to adopt. Federal law says you cannot discriminate against this couple. Yet you know the word of God teaches that a child is to be raised by a mother and a father. Not by a father and a father. Or a mother and a mother. Can you with a clear conscience provide adoption services do the same sex couple?

Brother I can go on with example after example. Just because there are federal laws on the books does not mean that these laws are enforced justly or with common sense. And in the case of same-sex marriage when these laws are enforced they go against the higher law of God.

Brother in the examples I gave above one can argue Romans 13 and say that the evangelical pastor, Christian wedding caterer, or the Christian adoption agency owner should obey federal law. But then they have to wrestle with their conscience knowing that federal law is in violation of God's law.

But brother let's take it one step further. You are an evangelical pastor who faithfully expounds and preaches God's word from cover to cover. You come to Romans 1:18-32. You know there are laws on the books at the federal level that make hate speech against any group, this would be the LGBT illegal. You know in your heart of hearts that if you preach through Romans 1:17 thru 32 which describe the origins of homosexuality you could very well land in jail. What do you do? Do you avoid going through that section of scripture. And move on to Romans 2? Can you do this with a clear conscience?

Mark do you see. Just because there are federal laws on the books. These laws are not always just. Or enforced with a sense of justice.

Brother, in the early centuries of the church, the believers faithfully obeyed the just laws of the Roman government when they did not contradict with the laws of God. But when Caesar passed a law requiring he be recognized as God. And that at a sacrifice be offered to him to show allegiance to Rome. The Christians had to disobey this law with the consequences that it entailed. The consequences being that many lost their lives for their faith in Christ.

Brother we do honor Romans 13 and submit to the governing authorities. But submission to governing authorities must end when the laws of temporal government conflict with the higher Eternal laws with God. What that point would be for each person must be directed by the Holy Spirit. But there will come a point when we say we must obey God rather than man.

I do not know if I have addressed your questions. But I hope some of my thoughts help.

The supreme court did not include specific wording but all the state courts who approved SSM did include such wording as Justice Roberts pointed out in his dissenting remarks stated: "Respect for sincere religious conviction has led voters and legislators in every State that has adopted same-sex marriage democratically to include accommodations for religious practice."

Also, several decisions of the United States Supreme Court strongly suggest that the First Amendment guaranty of religious freedom permits clergy to perform or not perform marriages according to their religious beliefs.

As to the original question I had, I apologize for being too dumb to understand what others are so clear about, but I still cannot bring myself to see how this imprisonment is specific religious persecution. Religious persecution by inference is persecution because of one's faith, is that correct? If that is the case, Ken Miller or anyone for that matter would have been convicted for kidnapping regardless of their religious convictions. When the judge handed down his statement he said as much. He wasn't agreeing or disagreeing with SSM, he was saying the law is the law...for everyone.

I think Ken suffered for righteousness sake...which is just as bad, but not the specific argument that many make, which we call "religious persecution". Religious persecution is when Ken would not be allowed to even preach Christ or hold a christian meeting in his home or any other location.

And speaking of holding christian meetings and being persecuted. Are you aware of the pastor in Arizona who was imprisoned last year for holding church meetings in his home? On the surface it looked like a clear cut case of religious persecution and I remember all the facebook posts about this. But when you dug a little deeper you found the other side of the story. The man lived in a suburban neighborhood and built a large separate building in his back yard for church meetings. This was not a residential building and was for the purpose of holding public meetings. As such it violated zoning ordinances. He didn't like this and did what he wanted to do anyway (probably thinking that he adhered to a higher law). The bottom line is that he lost...he was warned and told to stop and remove the building but he refused (or something like that). And in the end he elected to serve prison time rather than obey the zoning laws.

I hope you can see my point here. There are so many cases like this where we think we know what is going on until we hear all sides of the story. I just think that we ought to be careful with calling everything religious persecution when it does not go the way that we christians think things should go.

Perhaps differentiating between "suffering for righteousness sake" and "religious persecution" is splitting hairs, but it is important to know the difference when hearing about some of these so called hardship cases in the land of the free...where we practice religion free and without restrictions.

I understand what you are saying. If a non-Christian friend of Lisa's abetted her in the kidnapping because they felt sorrow for her plight and they were arrested we would not be calling it persecution.

To me this falls more in line with civil disobedience and its consequences.

Religious persecution (at least to me) is when a person is persecuted BECAUSE they are a Christian. If they start arresting pastors for refusing to perform SSM then that would be considered religious persecution because the law only affects Christians and other groups against SSM (likely Muslims, e.g.).

Florists, etc., are a tougher case, at least to me. Selling someone flowers is not aiding an abetting a sinful marriage. It is just selling flowers. It is no different than a Christian cashier at the grocery store who sells a case of beer to Mr. Jones -- for the 5th time that week.
